## **Graduation Rate**

In compliance with the Student Right to Know Act, found in Sec. 485(a) of the Higher Education Act of 1965, 34 CFR 668.45 Euphoria Institute of Beauty Arts & Sciences is required to disclose graduation rates as described below:

### **Graduation Rate Calculation**

The rates are calculated based on the Student-Right-to-Know (SRTK) Graduation Rate formula. It is based upon students who entered as full-time, first-time freshmen and graduated within 150% of the length of their program.

### **First-time Student**

A student who has no prior postsecondary experience attending any institution for the first time at the undergraduate level.
