## **Graduation Rate**

In compliance with the Student Right to Know Act, found in Sec. 485(a) of the Higher Education Act of 1965, 34 CFR 668.45 Lincoln Technical Institute is required to disclose graduation rates as described below:

### **Graduation Rate Calculation**

The rates are calculated based on the Student-Right-to-Know (SRTK) Graduation Rate formula. It is based upon students who entered as full-time, first-time freshmen and graduated within 150% of the length of their program.

### **First-time Student**

A student who has no prior postsecondary experience attending any institution for the first time at the undergraduate level.
